Indoor Play Space Permission

kcs has a new physical activity play space for your kiddo's in our lobby. Due to the restrictions with playgrounds, we wanted to designate a space for the children to play safely and have fun with typical playground activities.

This new area includes several gross motor activities available including a teeter-totter, a sensory roller, rocking bowls and our feature, a climbing wall. In addition, educators will bring in scooters, bikes, balls, various obstacle courses and literacy activities using a magnetic board.

The safety rules are posted and will be reviewed with the children before use. Only one child can use the climbing wall at a time and under direct supervision by a kcs educator.

The wall is meant to be a lateral wall with the child starting at the left and moving to the right and their feet not being higher than 3 feet. The appropriate mats are permanent. When the wall is closed, the mats cover the climbing wall and it cannot be accessed.

As a climbing wall is an uncommon activity, we want to make you aware of the risks of this activity and to have your permission for your child to use it. According to rock climbing associations, the major risks are with harnessing and ropes and high heights climbs, which do not apply to us. There is a chance children could slip off the wall and twist or break and ankle, but that risk is low. Children tend to jump down rather than slip on the easy routes. This risk is even lower when children wear proper footwear and running shoes are required.

Please read over the permission form and decide if you want to give your permission for your child to use the climbing wall. If you are not in agreement, your child will be able to use the Fun Space, just not the climbing wall.
